Dear Sir or Madam,

the **invitation link to the live version of the Union Database (UDB)** was sent today to the person in your company registered in the REDcert database under '1st contact person'. Please note, that the following e-mail address appears as sender: <u>DIGIT-CNS-ACC@ec.europa.eu</u>.

To use your personal e-mail address, please follow the instructions in the <u>step-by-step instruction</u> published on our <u>website</u> starting on page 8. In addition, your e-mail address must be verified by registering an EU login account so that you can open the invitation link sent today.

If your VAT-ID is correct in the REDcert database (format and type as specified by the UDB, see below), we have linked a valid certificate to your account in the UDB and also linked the operating sites based on the information stored in the REDcert database. In order to avoid technical difficulties with the UDB, we would like to ask you to regularly check and maintain your data in the REDcert database to ensure that it is up-to-date, complete and correct. Thank you very much!

NTR-ID:

The so-called NTR-ID is a national, unique identifier for identifying your company in the UDB. In the REDcert scheme, this means that you use your VAT-ID as the identifier in the UDB. We have already transferred this to the UDB for you based on the REDcert database. If the VAT-ID is not correct (see specifications in table), please correct it immediately in your user account in the REDcert database!

Before you enter initial stock levels in the UDB or carry out transactions, your VAT-ID must be entered correctly according to the following specifications! Since the beginning of April, it is no longer possible to change a commercial register number in the UDB to a VAT-ID (as required by REDcert). If you have not entered a VAT-ID, we cannot assign you a valid certificate and your UDB account **is therefore unusable.**

In addition to this communication, please read the latest information on your tasks and obligations in the Union Database (UDB) dated 8^{th} of December 2023 and 18^{th} of December 2023.

The initial stock levels should be stored from a self-selected date, as this initiates the personal start in the UDB. So if you retroactively report an initial stock level, the transactions must also be recorded from this date.

We would like to take this opportunity to apologize for the fact, that we have been unable to respond consistently to the numerous enquiries about the UDB due to the increased workload.
